1 PREAMBLE

We collect personal data about you that you knowingly and voluntarily provide in the course of or in connection with certain activities or transactions with us and/or our related, and affiliated or associated companies. Any additional personal data that we collect about you will depend on the nature of the particular activity or transaction.

2 Use of personal data

we currently, and/or may in the future, collect, use, disclose, or otherwise process your personal data for any or all of the following purposes:

providing or facilitating the provision of products and services to you; customer relationship management, including responding to, handling, and processing applications, requests, queries, complaints, and feedback from you; conducting research and analysis, including via the performance of surveys; designing products and services, and evaluating and improving the quality and content of such products and services; marketing the products and services of Mozark Pte. and our related, affiliated or associated companies; any other purposes for which you provided the information; complying with any applicable laws, regulations, codes of practice guidelines, or rules, or to assist in law enforcement and investigations conducted by any governmental and/or regulatory authority;

3 Disclosure of your data

Your personal data will not be disclosed to anyone outside of Mozark Pte, our related, affiliated or associated companies, and agencies and, and any other companies with which Mozark has directly or indirectly arranged services for your benefit. It will be treated in accordance with the applicable data protection and privacy laws and regulations including the General Data Protection Regulation (Regulation EU 2016/679 of 27 April 2016 or "RGPD")

4 Retention of personal data

We will retain your personal data for as long as it is necessary to fulfil the purpose for which it was collected, or as required or permitted by applicable laws. We will cease to retain personal data, or remove the means by which the personal data can be associated with particular individuals, as soon as it is reasonable to assume that such retention no longer serves the purpose for which the personal data was collected, and is no longer necessary for legal or business purposes.

5 Request to change data

You have a right of access, rectification, limitation, portability, opposition, deletion of your Data. You also have the option to set your instructions after death on the fate of your data (called post-mortem guidelines), under legal conditions.
